**THE PLANT PROTECTION (AMENDMENT OF SCHEDULES) REGULATIONS  
2025 MADE BY THE GOVERNOR UNDER SECTION 15 OF THE PLANT  
PROTECTION ACT (CAP. 9.02).**

**1. Citation**

These Regulations may be cited as the Plant Protection (Amendment of Schedules) Regulations, 2025.

**2. First Schedule amended**

The First Schedule of the Plant Protection Regulations (Cap. 9.02) is amended—

- (a) in column 1 by deleting paragraph (b) and substituting “All plants of the citrus family and parts of such plants except the fruits”;
- (b) in column 2 paragraph (b) by inserting “Barbados” after “Jamaica,”; and
- (c) by deleting paragraph (r) of column 1 and of column 2.

**3. Second Schedule amended**

The Second Schedule of the Plant Protection Regulations (Cap. 9.02) is amended—

- (a) in column 1 by deleting paragraph (e) and substituting “All plants of the citrus family and parts of such plants except the fruits”;
- (b) in column 3 paragraph (e) by inserting “Barbados” after “Jamaica,”; and

(c) by inserting paragraph (l) in columns 1, 2 and 3 the following—

“(l) Fruits of the Citrus Family	Under licence granted by the Governor and subject to being accompanied by a plant sanitation certificate from a responsible authority in the exporting country	All countries and places.”
